### **Grants Management**

Grants management is a continuous process used to administer grants and grant programs throughout the life cycle of the grant, from preaward activities to post-award activities, monitoring, and grant closeout. To be successful, grant managers must have a thorough understanding of the administrative requirements for Federal awards established in the Uniform Guidance, as well as the requirements of the Federal agencies themselves. ## OMB Circular A-123 Support

OMB Circular No. A-123 provides guidance to Federal Managers on improving the accountability and effectiveness of Federal programs and operations by identifying and managing risks, establishing requirements to assess, correct, and report on the effectiveness of internal controls. Agencies should establish internal controls for those risks identified by

management as requiring a formal system of internal control to provide reasonable assurance that objectives are achieved. Agencies should conform with the Standards of Internal Control in the Federal Government established by the Government Accountability Office (GAO), more commonly known as the Green Book. Watkins assists agencies documenting, establishing, and maintaining internal controls. We assist management with meeting the A-123 requirement to continuously monitor, assess, and improve the effectiveness of internal controls.

## **Data Analytics**
